RE: Transportation Worker Identification Credential (TWIC)

Brothers and Sisters:

Enclosed you will find all the information needed to obtain your TWIC card. This card will be needed by anyone performing work and needing unescorted access to any of the following facilities: Port of Los Angeles; Port of Long Beach; Airports; Refineries; Military; Government; Aerospace; or any area under the regulation of the Department of Homeland Security. This card may also be needed by another Local Union in order to dispatch you to work, should you have to travel to another local for work.

Let it be known that this matter should not be taken lightly; several industries have already been given the okay by the government, to import a number of workers, to help alleviate any employment problems, should there be a shortage of qualified, meaning credentialed workers.

I've provided an Information Sheet, a List of Disqualifying Offenses, a List of Identification Documents needed, a TWIC Disclosure and Certification form, a TWIC Enrollment Center address with hours of operation, and a map showing its location.

For those members on the out-of-work list, please contact me as Local 709 will subsidize your enrollment fee if you meet the TWIC card eligibility requirements.

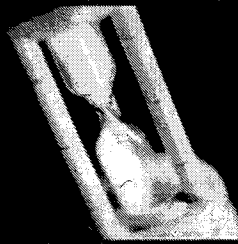

That's right - if you access a secure area of a port or vessel as part of your job, chances are you will need a Transportation Worker Identification Credential (TWIC), a biometric card that ensures only vetted workers can enter without an escort.



Enforcement at Your Port Begins April 14, 2009 Enroll for Your TWIC™ Today

You Will Need Your TWIC by This Date for Unescorted Access to Secure Areas of This Port

- **What is a TWIC and why do I need it?**

The TWIC is a biometric card that ensures only vetted workers are eligible to enter secure areas of a facility or vessel regulated by the Maritime Transportation Security Act (MTSA). You need it for your job and it's the law.

- **When do I need my TWIC?**

The Coast Guard declared that, beginning **April 14, 2009**, it will be mandatory to have a TWIC to access secure areas at ports located within the U.S. Coast Guard Captain of the Port Zones of **Houston-Galveston, Port Arthur*, Los Angeles-Long Beach, Guam and San Juan.**

- **How can I enroll for my TWIC?**

You can pre-enroll, find an enrollment center, and schedule an appointment online via www.tsa.gov/twic or by calling 1-866-DHS-TWIC. Otherwise, just walk in to the closest enrollment center to complete the initial application. You'll be notified when your card is ready - and you'll need to return to activate it.

- **How much does a TWIC cost?**

A TWIC costs \$132.50 and is good for five years. A reduced fee of \$105.25 is available to holders of the following:

- Valid Hazardous Materials Endorsement (HME) issued after May 31, 2005
- Valid Free and Secure Trade (FAST) Card
- Merchant Mariner Document (MMD) issued after Feb. 3, 2003
- Merchant Marine License (MML) issued after Jan. 13, 2006

If an individual obtains a reduced-fee TWIC, the expiration date will be based on the expiration date of the HME, FAST, MMD, or MML.

Applicants must present one of these documents at the time of enrollment to qualify for the reduced fee.

Remember: Individuals who fail to obtain a TWIC by the compliance date will be ineligible for unescorted access to facilities.

* Port Arthur originally had an earlier compliance deadline but this has been extended, as indicated above.

● What is TWIC?

TWIC is a common identification credential for all personnel requiring unescorted access to secure areas of Maritime Transportation Security Administration (MTSA)-regulated facilities and vessels, and all mariners holding Coast Guard-issued credentials. TSA will issue workers a tamper-resistant "Smart Card" containing the worker's biometric (fingerprint template) to allow for a positive link between the card itself and the individual.

● What can disqualify me from getting a TWIC?

-**Criminal:** An individual is wanted for any crime, under indictment for one of the disqualifying offenses, or has been convicted or incarcerated for those disqualifying felonies within prescribed time periods.

-**Immigration:** An individual does not meet the immigration status requirements

-**Security Threat:** An individual is identified as having a connection to terrorist activity.

If an applicant does not meet the qualification standards, then they have the opportunity to participate in the TWIC appeal and waiver process. See www.tsa.gov/twic for more information.

● What are the Permanent Disqualifying Offenses?

The following offenses are disqualifying if they occurred at any time:

1. Espionage/conspiracy to commit espionage.
2. Sedition/conspiracy to commit sedition.
3. Treason/conspiracy to commit treason.
4. Terrorism.
5. Transportation security incident. (Defined as a security incident resulting in a significant loss of life, environmental damage, transportation system disruption, or economic disruption in a particular area. A work stoppage, or other nonviolent employee-related, resulting from an employer-employee dispute is not a transportation security incident.)
6. Improper transportation of a hazardous material/comparable State law.
7. Explosives: Unlawful possession, use, sale, distribution, manufacture, purchase, receipt, transfer, shipping, transporting, import, export, storage of, or dealing in an explosive or explosive device.
8. Murder.
9. Bomb threats – making any threat, or maliciously conveying false information knowing the same to be false, concerning the deliverance, placement, or detonation of an explosive or other lethal device in or against a place of public use, a state or government facility, a public transportation system, or an infrastructure facility.
10. RICO (Racketeer influenced and Corrupt Organizations) violation/comparable State law, where an underlying act is one of the crimes listed above.
11. Attempt to commit the crimes in items (1)-(4).
12. Conspiracy or attempt to commit the crimes in items (5)-(10)

● What are the Interim Disqualifying Offenses?

The following are disqualifying if they happened within 7 years of the date of the application or the applicant was released from prison in the last 5 years:

1. Firearms: Unlawful possession, use, sale, manufacture, purchase, distribution, receipt, transfer, shipping, transporting, delivery, import, export of, or dealing in a firearm or other weapon.
2. Extortion.
3. Dishonesty, fraud, or misrepresentation, including identity fraud and money laundering where the money laundering is related to a crime listed here (permanent or interim disqualifying offense). This DOES NOT include welfare fraud or passing bad checks.
4. Bribery.
5. Smuggling.
6. Immigration violations.
7. Distribution of, possession with intent to distribute, or importation of a controlled substance.
8. Arson.
9. Kidnapping or hostage taking.
10. Rape or aggravated sexual abuse.
11. Assault with intent to kill.
12. Robbery.
13. Fraudulent entry into a seaport as described in 18 U.S.C. 1036, or a comparable State law.
14. RICO violations/comparable State law, other than the violations listed in permanent disqualifying offense (10).
15. Conspiracy or attempt to commit interim disqualifying offenses (1) – (14).

Outstanding wants, warrants, and indictments for any of the crimes listed above are disqualifying.

● Who needs a TWIC?

Merchant mariners and individuals who need unescorted access to secure areas of ports, facilities, or vessels regulated by the Maritime Transportation Security Act (MTSA) will need to obtain a TWIC.

● Why should I pre-enroll?

Workers can pre-enroll online at <http://twicinformation.tsa.dhs.gov>. Pre-enrollment can accelerate credentialing by allowing workers to provide biographic information and schedule a time to complete the application process in person. This eliminates delays at enrollment centers and reduces total enrollment time for each worker.

● How do I pre-enroll?

● What documentation is required for enrollment?

Applicants **must** provide the appropriate documents in order to verify their identity. They must provide one document from list A or two from list B:

List A (Any 1 of list below)

- Unexpired U.S. passport
- Unexpired Permanent Resident Card
- Unexpired Alien Registration Receipt Card with photograph
- Unexpired foreign passport
- Unexpired FAST (Free and Secure Trade) Card
- Unexpired MMD (Merchant Mariner Document)

List B (need two and one must be a government-issued photo ID)

- U.S. Certificate of Citizenship (N-560, 561)
- U.S. Certificate of Naturalization (N-550 or 570)
- Driver's license or ID card issued by a State or outlying possession of the United States
- ID card issued by a State or outlying possession of the United States
 - Must include a State or State agency seal or logo (such as state port authority ID or State University ID)
- Original or certified copy of birth certificate issued by a State, county, municipal authority, or outlying possession of the United States bearing an official seal
- Voter's registration card
- U.S. military ID card or U.S. retired military ID
- U.S. military dependent's card
- Consular Report of Birth Abroad
- Expired U.S. passport
- Native American tribal document
- U.S. Social Security card
- U.S. Citizen card I-197

INSTRUCTIONS: If you must obtain a Transportation Worker Identification Credential (TWIC), you are required to undergo a security threat assessment. To undergo this assessment, all applicants must provide information requested below and the appropriate documentation to verify their identity and immigration status (if applicable) as part of the enrollment process. Completed forms must be submitted in person at the beginning of the enrollment process. If you are initially disqualified, you *may* be eligible for a TWIC and should apply for a waiver, which gives you the opportunity to provide additional information and documentation to support your eligibility. You must wait for an *Initial Determination of Threat Assessment (IDTA)* letter before applying for a waiver.

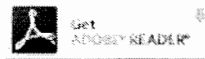
